Code of Conduct Contract

I understand and agree to abide by the following code and contract as a condition to participate in Indian Center, Inc. Youth Program activities. My signature and the signature of my parent or guardian are required and indicate our agreement with the code of conduct contract.

- I will dress appropriately, and in a fashion that represents modesty and self-respect.
- I understand that I am expected to participate in group activities, and that I am expected to arrive on time for all activities, and that I may not leave the premises without notifying and getting approval from a group leader or chaperone.
- I will strive my best in school and understand that the Indian Center, Inc. may contact school personnel for my grades and other school information.
- I will not steal, or take anything without asking; if I borrow something, I will return it in the same fashion it was borrowed in.
- I will respect the property of others, including personal property, as well as the event facility itself. If something breaks or becomes misplaced, I will notify an adult so that it can be fixed, noted by the facility manager, and make arrangements for my parents or myself to pay for what was broken or misplaced.
- I will avoid using foul language, inappropriate gestures, negative humor and sarcasm.
- I will not fight with others, verbally or physically, and I will be kind and courteous to other participants as well as non-participants.
- Extreme incidents involving issues such as fighting will apply the “THREE STRIKES” rule (participants will receive three warnings-upon receiving the third and final warning, I may be expelled from the program; temporary suspensions may apply to first and second warnings, at staff discretion).
- I will not bring or consume any alcohol, drugs, or tobacco at any Indian Center, Inc. activity, whether on Indian Center property or not.
- I understand that I am responsible for my own behavior while respecting the rights of all program participants.
- I will respect and cooperate with any directions given by any staff leaders, adult volunteers, or drivers.
- Violations of this contract can result in temporary or permanent expulsion from the program and its activities.
- I am responsible for complying with all of the provisions in this contract.
